In terms of Railway Board's letter No. 2022/E(RRB)25/08 dt. 28.07.2022 & 14.07.2022 and demand of Additional Indent for filling up 07 Additional Vacancies vide E.C.Railway's letter No. ECR/HRD/Rectt./RRB Panel/CEN NO. 01/2018 & 03/2018. dt. 09.02.2023, the names of following 07 waitlisted/standby candidates (Roll No. given below) of Technician category (category No. **34, 49 & 51**) of CEN 01/2018 are being recommended to E.C.Railway for further necessary action.
These candidates shall be required to give an undertaking that they will undergo fresh Medical Examination to ascertain their Medical fitness(Suitability) for the Post of Technician categories and in case they are not found fit, their candidature will not be considered. Medical Examination will be conducted by E.C.Railway as per extant procedure and candidates should submit their undertaking at the time of being sent for fresh Medical Examination.

Based on the performance of candidate in the 1st Stage Computer Based Test conducted from 09.08.2018 to 31.08.2018 and on 04.09.2018, 2nd Stage Computer Based Test conducted from 21.01.2019 to 23.01.2019 and on 08.02.2019, Aptitude Test conducted on 10.05.2019 and 21.05.2019 and the verification of the documents(DV) of candidates held from 16.06.2019 to 03.07.2019 and absentee DV on 06.07.2019 and on being found medically fit, the following 07 candidates from Extra List have provisionally been empanelled strictly as per merit for the post of Technicians Grade III, cat No. **34, 49 & 51** under CEN – 01/2018 against demand of Additional Indent by E.C.Railway. Their names are being forwarded to Principal Chief Personnel Officer, E.C.Railway, Hajipur. Further course of action on their appointment will be taken by Principal Chief Personnel Officer, E.C.Railway, Hajipur after due verification & ensuring fulfillment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste, Past Character/Antecedents/Affidavits where necessary etc. according to the Centralized Employment Notice No. 01/2018 and corrigendum issued thereto from time to time for which the candidates will be informed individually by the E.C.Railway, Hajipur. Candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.
