On the basis of the performance in the 1st Stage Examination (Computer Based Test) held from 28.12.2020 to 31.07.2021, 2nd Stage Examination (Computer Based Test) held from 12.06.2022 to 17.06.2022, CBTST held on 12.08.2022 and 27.08.2022 and the verification of the documents of candidates held from 05.12.2022 to 07.12.2022 and absentee DV on 09.12.2022 and on being found medically fit, the candidates with the following Roll Numbers who have opted for the allotted post as their first/highest preference, have been provisionally empanelled against the various categories of the posts of NTPC of Level-5 under CEN – 01/2019 and their names are being forwarded to Principal Chief Personnel Officer, E.C.Railway, Hajipur. All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.
